2/4/2016

- Per Jessica Beemer with COH; Due to lack of reports of hog activity the corrals have been picked up and the contract has been suspended
- Per Fred McCarty with RSCA; due to decrease in activity they have reduced from 2 corrals to 1 corral.
- As of May Parks Meeting, reports of moms with babies

9/1/2016

Reported there is lots of activity in Royal Shores; Kings Point; and Reserve at Kings Point along with East End Park lots of female pigs with piglets

10/6/2016

Not as many reports and only 8 captured on edge of East End Park near waterfront near Friednswood property north of Royal Shores.

11/3/2016

The most reports are in the areas of Kings Point on Cobblestone ; Redwood Bridge Trl.;Lark Valley;Pebble Stream.
Fosters Mill reports are in the areas of Golden Pond; and Riverchase is Sweetstem and Glade Hill
Geraldo would like to place a corral for \$400 but we need a location and we are working with him on this suggestion.

12/1/2016

The reports are from the Reserve at Kings Point and Kings Point areas. Scenic Shores was hit this time.
Hogs captured were in the back side of RAKP and KP
The RAKP donated funds to place a corral near the waterline behind RAKP and KP area to help catch the hogs before getting up into the resident properties.
The corral parts have been ordered and the corral will be placed shortly by Garcia.

1/5/2017

Talked to Geraldo, hogs do not come out as much at night when its cold; they are on the islands during the day. They will have the new corral up this month.
The hogs that were captured were near Riverbend and the other on Kings Point Trail greenbelt. Large hogs not seeing as many moms with piglets at this time.

2/2/2017

I have not been able to talk to Geraldo for the count, when I receive update I will send this out by email.

3/2/2017

The reports have been in the area of the Deerwood Country Club and Redwood Bridge Trl (KPCA). Behind KPPTA and East End Park

4/6/2017

All three reports have come from Redwood Bridge Trl. Area and Geraldo has captured 20 this past month.

5/4/2017

There have been no reports of feral hogs for the month of April, 2017. Our hog tracker has captured 8

6/1/2017

In the past week there have been 4 reports of hog damage in Kings Point area. Our hog tracker has captured 11, some in corral and others singles.
We have had sightings of the coyotos all through Kingwood. In front in Deer Ridge Estates and back off Mills Branch Road. Two small dogs reported killed in Kings Forest.

7/6/2017

All the reports of hogs in June and this week have been near the Deerwood Country Club where our trackers are not to go. I have asked the residents to contact Deerwood.

8/3/2017

Few reports this last month, a couple from Kings Point that backs up to East End and 2 from Deerwood CountryClub area. At time of printing we had not received how many the hog tracker captured.

9/7/2017

We have not heard any activity in several weeks, early August there were signs of hogs In East End Park.

10/5/2017

There has been no activity since the flood.

11/2/2017

Lots of activity now - traffic of the hogs are being reported in East End Park and all along the waters going south to Royal Shores

12/7/2017

There has been activity in the entry of East End Park;front of Riverchase; eastside of Kings Point; and Royal Shores

9/6/2018

Only one report from Reserve at Kings Point/Cobblestone near East End

10/4/2018

Hogs reported in area of Fall Orchard;Cobblestone Hill;Redwood Bridge Tr.;Magnolia Trace

Other reports from residents of Royal Shores received in the office that they were having hog damage in the Courts which indicates that the hogs are all along the waters edge.

11/1/2018

Riverchase entry/Kings Point/Reserve @ Kings point/ and Royal Shores along the end of East End Park and shoreline is where the hogs are being reported.

12/17/2018

Very few reports of hog damage but Royal Shores has been active.

1/3/2019

Eleven incidents reported mostly in Royal Shores or eastside of Reserve at Kings Point near East End

2/7/2019

twelve (12) reports n RAKP and Kings Point area and one (1) report in Bear Branch near Creekwood on flood control ditch

Royal Shores has there corral active and waiting to catch the large group all at once and have removed.

3/7/2019

7 reports of hogs in February and 0 March so far. Kingwood Greens signed an agreement with our hog tracker.

Hog tracker captured 11 in February which is great; Royal Shores removed 8

5/2/2019

Kingwood Greens is getting hit; Kingwood Country Club notified of help needed to clear their hogs from the undeveloped area near KW Greens

Roya Shores is receiving no current sightings of hogs. East End Park there has been only one sighting in the early morning hours.

5/30/2019

Kingwood Greens has reported less this month;Fosters Mill had more and Kings Point reported twice.

This times me that KW Country Club and Deerwood Country Club plus Flood Control have assisted with hog removal.

7/11/2019

Started in FM Estates in June, then RAKP, and now Kingwood Greens again

8/1/2019

Activity is East End Park through KPTA to back of Reserve @ KP. Kingwood Greens has reported several hits; and then a surprise hit reported from Trailwood on Cedar Falls which is first street up from Deer Springs near DR Park so all authorities have been notified. . HPD Lake Patrol; Harris County Flood; KW Country Club; and hog tracker.

9/5/2019

There were 33 reports of hogs since last meeting. Kings Point; Kingwood Greens; Riverchase; and Fosters Mill were damaged. Contact with Clubs of Kingwood was made; HCFC was called; and Kingwood Greens has hired hog hunters for their village. Royal Shores has put up their cameras again and monitoring activity.

10/3/2019

There were 22 reports of hogs and most were in Fosters Mill, Kingwood Lakes, Kingwood Greens, and Kings Point

11/7/2019

There were 55 reports of damage by hogs. Kings Point, Kingwood Greens, Fosters Mill, Sand Creek, Kingwood Greens Called Harris County Flood and got a contract for their hog tracker, he wants to meet to learn the hogs bedding areas in undeveloped land. I put him in contact with KWCC also. He hunts with dogs also. He has contract with HCFC. Been doing this for 20 years and wants to help us. Doesn't have insurance but we will work on this.

12/5/2019

There were 55 reports Activity was in Kings Point Scenic Shores and other areas; Kings River south of Kings River Dr.; Reserve back up to KPTA-East End Park; Royal Shores at Courts and Eagle Nest area; Fosters Mill Sunshine Point and Bluff Creek near Deerwood CC; Sand Creek Pecan Park off flood control ditch Geraldo - 10 East End Park and Mike removed 5 in Deerwood CC and 5 in Kings River

12/20/2019

Only 6 reports of hogs since 12-5-2019. Kings River 1; Sand Creek 2; Kings Point 1; Enclave 1; Royal Shores 1 Mike and Geraldo have both been tracking. Mike removed 3 hogs from Pecan Park SC; Scenic Shores 7 piglets; he tracked the bedding areas of Royal Shores and hunted this week. I'm asking for number captured.

1/2/2020

Fewer reports now so looking real good.

2/6/2020

12 reports and several where from the same areas. Both hog trackers are doing well, Garcia in East End and Mike in all others.

3/5/2020

9 reports of hog damage being from KP, RS, FM, and Barrington Garcia captured 4 in East End and Mike has been in all other areas but has not been able to capture the hogs because they are seen near the water of Lake Houston and they run and swim to the islands. He will be in the Royal Shores again tonight. He reports that they are small groups in Barrington but other places just a couple at a time.

April no details

May no detail report

4-Jun-20

Got report from Mike, will be out this week to cover Kings Point since there have been more calls and emails. Also hunting in Royal Shores, there have been reports by email.

7/2/2020

Garcia has not been able to hunt recently; best dog died; training young dogs; gathering a current report from him Mike has hunted but only able to capture 2 recently. The hogs are heading to the water and swimming to islands once his dogs have gotten on the scent. HPD Lake patrol has been called again to check the islands.

7/9/2020

Mike reports he is having issues with COVID at his business with 5 workers out sick; had to lay off some others; had a scare in his family and all were tested; just hard times right now but will try to get out to hunt real soon. Garcia has not reported in and I'm trying to contact him.

8/6/2020

Mike has not been able to hunt July but starting back now. He will keep in touch. Geraldo has hunted and captured 2. Its been very quiet; only one report in July and nothing more.

9/2/2020

They have both been out to the East End and along trail behind Kings Point where the hogs have been noticed. Not much hunting going on right now, Mike still working around COVID and Garcia is trying to find more dogs.

10/1/2020

Mike has not been able to come out as often since COVID. He is having to travel more now and is working to find others that can assist us while he is short employees. Garcia is now hunting more and has been more active.

11/5/2020

Mike is back with a couple of friends to help him. He has been in the Kings Point area but hogs are running so only captured/killed two Garcia is tracking in East End Park area and reports he captured/removed 6 Royal Shores has put in corral and has captured 5 so far but still getting damage Kings Point Trail has placed a corral and I'm waiting on number so far but know a deer was caught in corral and had to be killed by game warden. So there has been lots of sactivity but there is hunting and corrals being used to get this back under control.

12/3/2020

Mike has been hunting and killed 4 - checked Deer Ridge Park but can't find the hogs he suspects they got back o the drainage ditch or went toward River Grove to water Garcia has been hunting EE and captured 7 Ryoal Shores corral but had one road kill incident that removed one hog. Kings Point Trail corral has not been successful and this is being verified, So less reports and less hog removal but we are staying on the tracking to make sure it doesn't increase again.

1/7/2021

2/4/2021

There were 5 reports and all in Stately Oaks/Kings Point area.

3/4/2021

There were five reports of hog damage in the Kings Point area.

One report of hog running down the middle of the street of Clear Ridge in Sherwood Trails

no damage reported. Just thought you would enjoy a laugh, the Woodridge property is behind Sherwood Trails and Elm Grove.

Maybe they are coming from that property, not sure where the nearest waterway would be from the middle of the subdivision.

4/1/2021

There was only one report of hog damage since our last meeting from Kings Point area. The hog trackers were notified.

Geraldo reported he came up on a sow with piglets ; but Mike reported unsuccessful this month.

Kings Point Trail had a corral for two months and captured nothing. Royal Shores removed their corral also.

5/5/2021

Kings Point had 5 reports behind stately oaks area against East End Park; Royal Shores had 1; and East End Park near Otter Creek

there was report of several hogs at 3 p m - the hogs were not afraid of the people but the people got out of the area quickly.

There are no corrals in Royal Shores or Kings Point now. No luck with corrals,

No reply in time for meeting from Mike.

6/3/2021

Kings Point had 7 sightings of hogs in the same locations by the same two residents.

East End Park had 1 report of hogs and Royal Shores 2

The weather has prevented the hog trackers from safely hunting in the forest areas. Ground is muddy.

7/1/2021

Only one report in the area of Reserve at Kings Point back side being East End Park

Geraldo reported there are very few fresh tracks and with rain, they are bedding down and not moving as much. He was able to capture 2 smaller hogs.

Mike is now getting out and looking in all areas, there is little activity.

8/5/2021

There Has been 5 reports from same person off Stately Oaks in Kings Point. Today we had a report of hogs on the Harris County Flood Control ditch between Fosters Mill and Sand Creek along Kingwood Drive.

9/2/2021

No reports of hogs; hog tracker reports there is less sightings of any hogs. More coyotes right now.

10/7/2021

Two reports from the Sand Creek area of Forest Garden near the Harris County Flood Control ditch, I reported this to Geraldo.

Then I received one report from Royal Shores on 10-5-2021 on siting at the pier park on waters end. Both of these were sent to the hog trackers.

There was a report of a dead hog on the Greentree Sand Trail near the Flood Control Ditch so hopefully the damage was from that one and its gone.

11/4/2021

Geraldo got 2 in sand creek ditch and 3 at East End Park.

Mike also worked the flood control ditch and captured 2 near Sand Creek.He was going to move up the HCFC ditch on both Fosters Mill side and Sand Creek side of Kingwood Drive.

12/2/2021

I was able to speak with Geraldo, they didn't get to hunt as much due to Thanksgiving holidays, but did look into the Sand Creek and the Stately Oaks reports.

They got 4 in total this month. I have contacted Mike but I didn't hear back. I will update the report as soon as I hear from him.

I know he has been out just don't know the number. He worked the HCFC ditch along Sand Creek across Kingwood Drive into Fosters Mill and around the Enclave HCFC ditch.

1/6/2022

Dec 16th Royal Shores Courts ares reported hog damage. Sand Creek resident reported hog damage in the median of Mills Branch Rd, January 3, 2022 .

Royal Shores resident reported mama pig with piglets on the streets.

2/3/2022

1-3-2022 Royal Shores reported along Royal Creek a sow and piglets were sited.

1-22-2022 Royal Shores resident reported hog damage on the slopes in the Courts area

1-22-2022 this was reported again

1-31-2022 Kings Point Resident reported damage along Redwood Bridge

2-1-2022 Royal Shores resident reported damage at the Royal Shores Pier Park

These were sent to Garcia and he responded he would go inspect in the wooded area next to the park.

3/3/2022

2/1 report from Royal Shores hog siting Royal Shores @ S. Royal Point and their pier park.

2/7 resident reported hogs on Cobblestone - SE corner of Hidden Lakes @Kingwood Dr.

2/28 Kings Point resident reported hogs at Valley Heather & Peachtree

Leslie reported they had captured 7 in East End Park area and Mike reported he had hunted the flood control ditches and captured 1

4/7/2022

3-25 report from Kings Point Stately Oaks of hog damage, this was sent directly to Garcia

Mike has reported that he will not be able to hog track for us but has a friend that is interested. We are working to interview with him shortly.

Tanner already has his insurance in place and has worked with Mike on Harris County Flood Control properties.

Garcia reports they had captured 5 hogs this past month in the area of back side of Kings Point on the East end Park property.

5/5/2022

The Redwood Bridge Trail area has been reported 3 times this month and one report in Royal Shores in the courts,

The hog trackers have both been told to investigate in this area. The area off Stately Oaks continues to be a problem but trackers are working this area also.

This is along the greenbelt of Kings Point that backs up to East End Park. Tanner is getting familiar with the area.

6/2/2022

The Redwood Bridge Trail area has been reported 2 times; Stately Oaks 1 time, Chestnut Peak was hit two nights in a row.

Garcia reports they captured 4 adult hogs and several piglets. I was unable to visit with Tanner so I don't know if he captured any or not.

7/7/2022

6-10-2022 Only one report in Reserve at Kings Point , Orchard Canyon and one in Kings Point today on Redwood Bridge.

8/4/2022

7/7 - Kings point at Redwood Bridge Trl.

7/29 - Kingwood Greens on Island Greens

8/4 - RAK on Magnolia Trace, hogs sited on Kingwood Drive and on Hidden Lakes

9/1/2022

reports in Rakp & Kings Point were high with 15 reports on Kingwood Dr @ Hidden Lakes; Cobblestone Hill;Chestnut Peak;Redwood Bridge Trl;Orchard Canyon Ct; the hog trackers were sent this information as it was reported and were able to address the problem areas.

10/6/2022

9-1 Kings Point Redwood Bridge Trl.; 9-4 Kings Point Chestnut Peak; 9-4 same again; 9-13 RAKP orchard Canyon; 9-17 Redwood Bridge Trl; 9-26 KP redwood Bridge Trl; 9-29 Kings Point Walnut Knob Ct.

11/3/2022
